HB326-RxP BILL

Dr. Randolph called attention to HB326 (Seitz, Gavarone), and briefly reviewed the Board's previous consensus statement relative to preparedness to implement prescriptive authority through rule writing and administrative support. Dr. David Hayes, Ohio Psychological Association (OPA) Liaison to the Board, reported that OPA is working with the sponsors and stakeholders to foster an accurate understanding of the bill, and emphasized the transparency of the process beginning with the bill's sponsors.

PSYCHOLOGICAL WORK SUPERVISION PROHIBITIONS

Dr. Hedges led a discussion about prohibitions in Board supervision rules specific to Psychological Work Supervisees being prohibited from the functions of psychological diagnoses, psychological prescriptions, nor psychological client supervision. There was consensus that these hazardous practices are necessarily occurring when a Work Supervisee is delegated other hazardous practices including, but not limited to, psychological psychotherapy. Concerns were heard relative to confusion that these prohibitions might cause license holders in professional practice, and hypotheses about the genesis of the prohibitions were discussed. Dr. Hedges and Dr. Ross agreed to undertake review of this issue in a stakeholder meeting, during which updated training requirements and supervision rules will be drafted for Board review and action.

CALL FOR COMMENTS:**ASPPB MANDATORY SUPERVISION GUIDELINES**

There was consensus that the initial draft of the ASPPB guidelines distributed with the agenda appeared to be a thoughtful and positive addition to professional guidance available to member boards. Dr. Ross was directed to provide this feedback to ASPPB.
